#### EXHIBITOR DATES

The exhibition will take place between 8am and 5pm on Wednesday 23<sup>rd</sup> and Thursday 24<sup>th</sup> April 2008. The booth set-up will start on Tuesday 22<sup>nd</sup> at 5.30pm.

#### THE EXHIBITOR AREA

The exhibitor area is located on the hotel conference floor (1st floor). As you can see on the plan on the next page, CDISC will offer you two different exhibition options:

1. A booth within the conference room at the rear
2. A booth outside of the conference room

The whole conference floor will be used for all coffee breaks (morning and afternoon) and lunch to guarantee a continuous stream of visitors at the exhibitor's booth during the two days of the CDISC European Interchange 2008.

#### THE EXHIBITION COSTS

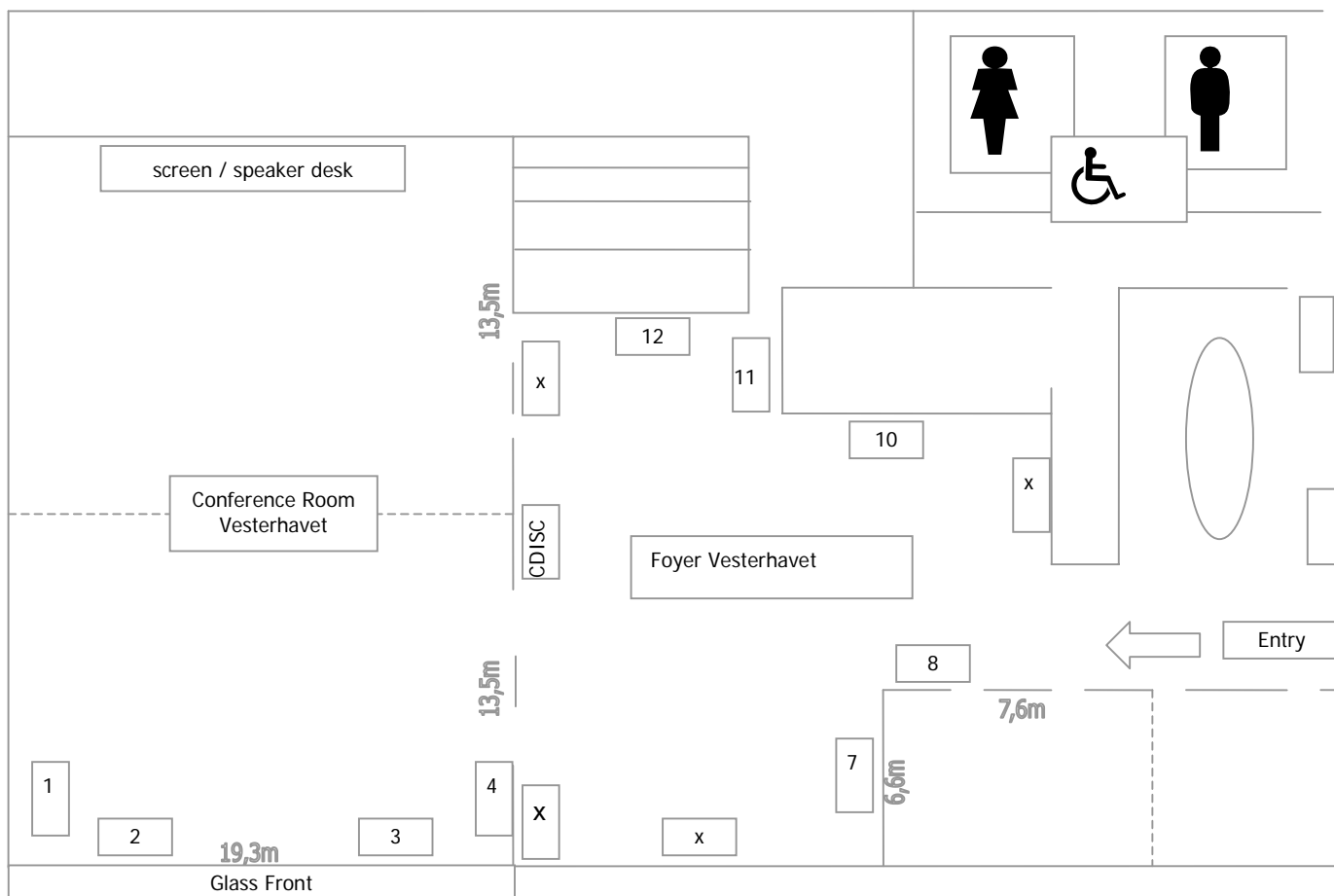
3 x 3 meter space will cost **\$688** for a CDISC Benefactor, Academic or Non-Profit institution, **\$1238** for a CDISC Corporate Sponsor, **\$1788** for a CDISC Corporate Member, **\$2063** for an Associate Member and **\$2750** for a non-CDISC member. This includes 2 conference registrations, 1 table, 2 chairs, and electrical supply. Additional expenses for services such as drayage, phone, internet connection, etc. will be available through the hotel at the cost of the exhibitor.

Booths will be assigned on a first-come, first-served basis and once exhibitor application has been received, an electronic invoice (or receipt/confirmation if credit card information is submitted) will be sent via email within 5 business days, confirming your space.

### THE BOOKING

2. On the floor plan you find numbers indicating the location of each booth. Please choose your preferred number.
3. Booths will be assigned on a first-come, first-served basis.
